3 Description

3.1 Product status change

The NORA-W101 and NORA-W106 Wi-Fi and Bluetooth Low Energy 5 modules and the corresponding evaluation kits EVK-NORA-W101, EVK-NORA-W106, and USB-NORA-W106 have been released to Initial Production.

3.2 Certification and qualification

NORA-W10 modules are compliant with the Radio Equipment Directive (RED) and are certified as modular transmitters in: Europe (RED), Great Britain (UKCA), US (FCC), Canada (IC / ISED RSS), Japan (MIC), Taiwan (NCC), South Korea (KCC), Australia / New Zealand (ACMA), Brazil (ANTAL), and South Africa (ICASA). For the current approval status of the certification in each country, see also the NORA-W10 system integration manual [\[3\]](#). The modules are also qualified in accordance with the Bluetooth 5.0 specification.
