3 Description

The u-connectXpress software v8.4.0 for ODIN-W2 series modules has been released. The new software is described in the release note [1]. Primarily the new software enables compliance with the EU RED articles 3.3d (RED cybersecurity, EN 18031-1:2024), applicable to Internet-connected radio equipment placed on the European market from August 1, 2025.

The ODIN-W2 DoC [2] has been updated with compliance to EN 18031-1:2024 with software v8.4.0.

ODIN-W2 modules flashed with software v8.4.0 can be ordered with the new ordering codes **ODIN-W260-07B** and **ODIN-W262-07B**.

4 Schedule

ODIN-W2 u-connectXpress v8.4.0 is available for download [3].

Orders for the new ordering codes ODIN-W260-07B or ODIN-W262-07B can be placed now. Orders will be confirmed as soon as the new ordering codes are available in production, scheduled for second half of July 2025.

5 Customer impact and recommended action

- A review of the software updates described in the release note [1] is advised.
- Customers selling products within the EU are recommended to review the applicability of the EU RED articles 3.3 for their product and consider an update of ODIN-W2 software to v8.4.0.
